EZI-ROC - adwater GENERAL PRODUCT INFORMATION

These products are manufactured using a cement-bound matrix, reinforced with synthetic fibres and are recommended for ornamental purposes only.

TRANSPORTATION - All products should be handled and placed carefully. Do not lift larger products, e.g. cliff panels, alpine ponds, by their extremities. Do not allow finished surfaces to rub against each other during transportation.

COLOURS - Colours are achieved through oxide tinting of the cement matrix and/or surface applied tinted acrylic polymers. Varying degrees of colour loss can occur through exposure to ultra-violet light or hostile conditions, e.g. salt or chlorinated waters, and through general ageing. Water courses can lose colour through abrasion, but often algal growth and will create an even more natural look. Colours may vary between two of the same products. As in nature no two rocks are the same, and this is often the case with **EZI-ROC** or **adwater** products. Because of their irregular nature, shrink cracks can occur. These are inherent in any cement based product, but generally will not compromise the integrity of the product because it has a fibre reinforced matrix. Surface efflorescence may also occur.

TESTING OF WATER FEATURES - All products incorporate a body of water are tested at least to the water level that we consider optimum for the product before leaving the manufacturers premises. Watercourses are also tested, however in some cases e.g. waterfall rocks the bowl above the waterfall is tested only. It is recommended that a piece of pond liner or plastic is under and used under and behind these units to redirect water that may seep through or under the artificial rock.

INSTALLATION - Waterfeature ponds and plain ponds should be bedded in a dampened mix of sand and cement 50-100mm thick that will harden and provide good support for the floor and walls of the product. Do not stand inside ponds at any time.
